Dear Peter Blazeski,

The Dutch Council for Refugees has received your email.

We are very sorry to hear about your difficult circumstances.

The Dutch Council for Refugees is a non-governmental organization that defends the right of asylum seekers in the Netherlands to a fair asylum procedure. Because of the complexity of an application for asylum we are not in a position to give you specific and personal advice. We are only able to help asylum seekers and refugees in the Netherlands. Furthermore, it is not possible to apply for asylum at a Dutch Embassy. As a rule an asylum application has to be lodged in person at the application centre in Ter Apel, the Netherlands.

Some more general remarks:

1. Should you have the opportunity to travel to Europe, the following is very important: in general the EU-country that issues you a visa or the EU-country of arrival is responsible for handling your asylum application (except if you are an unaccompanied minor). For example, if you enter Europe via Italy and you continue to the Netherlands and file a request for asylum here, Italy is responsible for handling your asylum request. As a result, the Dutch authorities may send you back to Italy.

2. The Dutch authorities expect you to submit all possible information and documents concerning your identity and nationality, for example your passport, identification card, birth certificate, certificate of marriage etc. These documents are of great importance. Also, the Dutch authorities expect you to explain how you travelled to the EU and the Netherlands and submit all documents you may have, such as plane tickets, boat tickets, bus tickets and so on.

Failing to deliver these documents does not mean your claim for asylum will be rejected, but it may be more difficult to prove to the Dutch authorities that you are in danger and need protection (asylum). It may be dangerous to bring these documents with you. In case you could have your documents sent to you, after you have arrived in the Netherlands, please contact the local office of the Dutch Council for Refugees as soon as possible.

3. To qualify for asylum you need to prove that your life/well-being in your country is in danger, that you are at risk from the authorities and/or from a non-governmental actor, from which the authorities cannot or will not protect you. The Dutch authorities expect you to state clearly why you are in need of protection. Any document that you may have to substantiate your claim may be of importance, for example an article from a recognized newspaper, a threatening letter, specified information from the Internet, a membership card (in case of persecution on political grounds) or a baptismal certificate (in case of conversion to another religion). If you were not in a position to bring any documents with you, but could have documents sent over to the Netherlands, contact the local office of the Dutch Council for Refugees as soon as possible.

If your life is in imminent danger please go to UNHCR (United Nations Refugee Agency) for support. For more information about UNHCR we would like to refer you to their website: <http://www.unhcr.org/contact-us.html> (select a field office).

For information to get resettled to the Netherlands, please see information from UNHCR, the refugee agency of the United Nations. UNHCR is the agency which decides in the first place which refugees qualify for resettlement. The procedure for resettlement is laid down in the following link: <http://ind.nl/EN/Documents/6079.pdf>. Unfortunately, the chances to get resettled to the Netherlands are very slim.
